

# Wilson, Criminal District Attorney

In our office, we consider hundreds of child abuse cases each year. Our Special Victims unit is a team of prosecutors specially-trained to handle the unique and highly sensitive challenges of crimes involving our community's most vulnerable victims: children, the elderly and disabled.

An Update from Sharen Wilson **Criminal District Attorney** 

In a recent child sex abuse case prosecuted by our office, a seven-and-a-half-year old boy was sexually assaulted by his mother's live-in boyfriend on several occasions. Once, the mom was going

to run an errand and the child begged her to let him go to the store with her. Mom unknowingly said she would be back quickly and that the child needed to stay at the house with Mom's live-in boyfriend. Later the child described acts of sexual abuse to his mother and she immediately reported what her son said to the police.

In child abuse cases, the victim is interviewed by a highly-skilled and -trained forensic interviewer. The forensic interview is a fact-finding conversation where the trained professional asks non-leading questions. Forensic interviewers are trained in child development and linguistics, which allows them to communicate with children of all ages and at all stages of development. Children who are victims of sexual abuse also receive a comprehensive medical exam to make sure their bodies are okay, and to receive treatment if necessary. This child was referred to Cook Children's Hospital for examination following his forensic interview.

At trial, the now ten-year-old child appeared for court dressed smartly in a button down and bow tie. The child's courage and demeanor had a profound effect on the people in the courtroom - including our prosecutors. He testified fearlessly to the multiple sex acts he was forced to endure. At the conclusion of the trial, the twelve jurors stood up for the victim and sentenced the defendant to 47½ years in prison for continuous sexual abuse of a child. After trial, jurors told prosecutors the extra seven-and-a-half-years were to honor the victim, because he was seven-and-a-half when the abuse started.


April is National Child Abuse Month, and Texas State Law requires that anyone "having cause to believe that a child's physical, mental health or welfare has been or may be adversely affected by abuse or neglect" MUST report the cause immediately. Failure to report child abuse is a misdemeanor punishable by law.

Suspected child abuse is not something anyone should ever keep quiet or "mind their own business." If you suspect a child you know may be abused, please make a report. If a child confides in you, believe the child and let law enforcement, medical, and forensic experts sort out the facts.

## **Recent Cases of Note**

#### The State of Texas v. Rodolfo Arrellano

Rodolfo Arrellano's case received national attention when in April 2016 he was charged with tying a concrete block around the neck of his estranged wife, Elizabeth, and throwing her off the Lake Worth bridge. Given the brutal circumstances, once the Capital Murder case was filed against Arrellano, the decision was made to seek the death penalty.

Arrellano vehemently denied any role in the crime, but after two years in prison and nearing his trial date, his attorneys contacted prosecutors to let them know he was willing to accept responsibility and plead guilty to Capital Murder in exchange for life in prison without parole.

The victim's family, who are raising the former couple's 4 young children, were given the opportunity to face Arrellano in court and give allocution statements about the tragedy he had committed against their beloved daughter, sister, and friend.

#### The State of Texas v. Kevin Ashley Parnell

Kevin Ashley Parnell was charged with the September 2017 murder of Fort Worth resident Sammie Jones.

Parnell strongly disliked his stepdaughter's boyfriend, who was Jones' roommate. After a day of heavy drinking and sending the boyfriend threatening messages via Facebook and text, Parnell went to the house shared by Jones, Parnell's stepdaughter and her boyfriend. Jones, who Parnell did not know, answered the door and attempted to calm the irate Parnell. After a short verbal exchange, Parnell shot Jones and fled. Witnesses tried to render aid, but Jones died at the scene.

Due to many racial slurs used in his messages to the boyfriend, our office also requested a finding against Parnell based on bias or prejudice. Although it would not have legally affected the penalty range for 1st degree felony Murder and was not found by the jury, we felt the evidence was so compelling it must be included in the charges against Parnell.

**Sentence:** 46 years. 2 years in prison (for Tampering with Evidence)
