Formulary Updates

New Dosages of Three Medications Used To Treat HIV in Infants and Children Have Been Approved for Addition to the THMP Formulary:

- Tivicay PD (dolutegravir) 25 mg
- Isentress (raltegravir) 25 mg
- low-dose Biktarvy (bictegravir 30 mg/emtricitabine 120 mg/tenofovir alafenamide 15 mg)
- DSHS is able to support these additions within existing monies and has approved adding these pediatric medications to the formulary.
- Please submit a new THMP [Medical Certification Form \(MCF\)](#) for any infants and children in need of these new medication doses.

New Medication added to the formulary:

- Rukobia (fostemsavir tromethamine), 600 mg tablets, #60 per bottle
