COMMISSIONER'S CORNER

It seems like yesterday when we started this journey as your County Commissioner. It was January 1, 2007 and we're now into our seventh year. This has been the greatest honor I have ever received to be able to serve you as Commissioner.

In Precinct 3, we're all about Transportation. Our 4th Annual Northeast Tarrant Transportation Summit will be held on Friday, February 15th at the Hurst Conference Center. This year's conference will provide our annual update on the two major projects in our area: The DFW Connector and The North Tarrant Express. Both projects have had a major impact on our driving habits the past 3 years, and the completion will provide decades of improved mobility. Our Keynote Speaker, **Ross Perot, Jr.** will be speaking about the importance of transportation infrastructure as it relates to the success of our business environment. Our first seminar will include a presentation featuring the TEX Rail/Cotton Belt Line, a 62 mile regional rail line connecting Tarrant, Dallas, Collin and Rockwall counties. The second seminar will cover Transit-Oriented and Transit-Ready Development and how it can transform the Marketplace. The third seminar will detail the ABC's of the RTC (Regional Transportation Council): the process of Regional Transportation Planning for the North Central Texas area. Our goal at Precinct 3 is to inform and educate the public about the transportation systems that are available and the options involved when improving mobility. If you have visited our Hurst office in the past 2 months, you have probably noticed the architectural drawings that we have placed on most of the walls to display the new Precinct 3 Sub-Courthouse planned on this site in the near future. (See page 4) We will be vacating this site in the next 30-75 days to make room for the new building. If you've ever voted here, waited to pay your taxes, registered a car, attended a meeting, visited the Constables, County Clerk, Juvenile Services, or the JP Court then you know how crowded the building and the parking area can become. We plan to solve that problem and provide additional services such as a Passport Office, expanded Tax, County Clerk, Constable, JP Court, Credit Union, Community Room, and Commissioners facilities. The JP Court, Constables, and Commissioner will be temporarily moving to the Southlake Town Hall facility. Juvenile Services will relocate to another location. The Tax Office, County Clerk, Credit Union, and some of the Constables will be temporarily located at a leased facility near Harwood and Norwood in the City of Bedford.

Check out the article about our newest elected official in Precinct 3, Constable Darrell Huffman. Constable Huffman has been very involved in our community and is doing a great job.

Coffee with the Commissioner will be this Friday, February 8th at the Hurst Sub-Courthouse. This will be our last Coffee in this building. We will continue to have them at the Southlake Office for the next 18-20 months. Thanks for being part of our Journey.

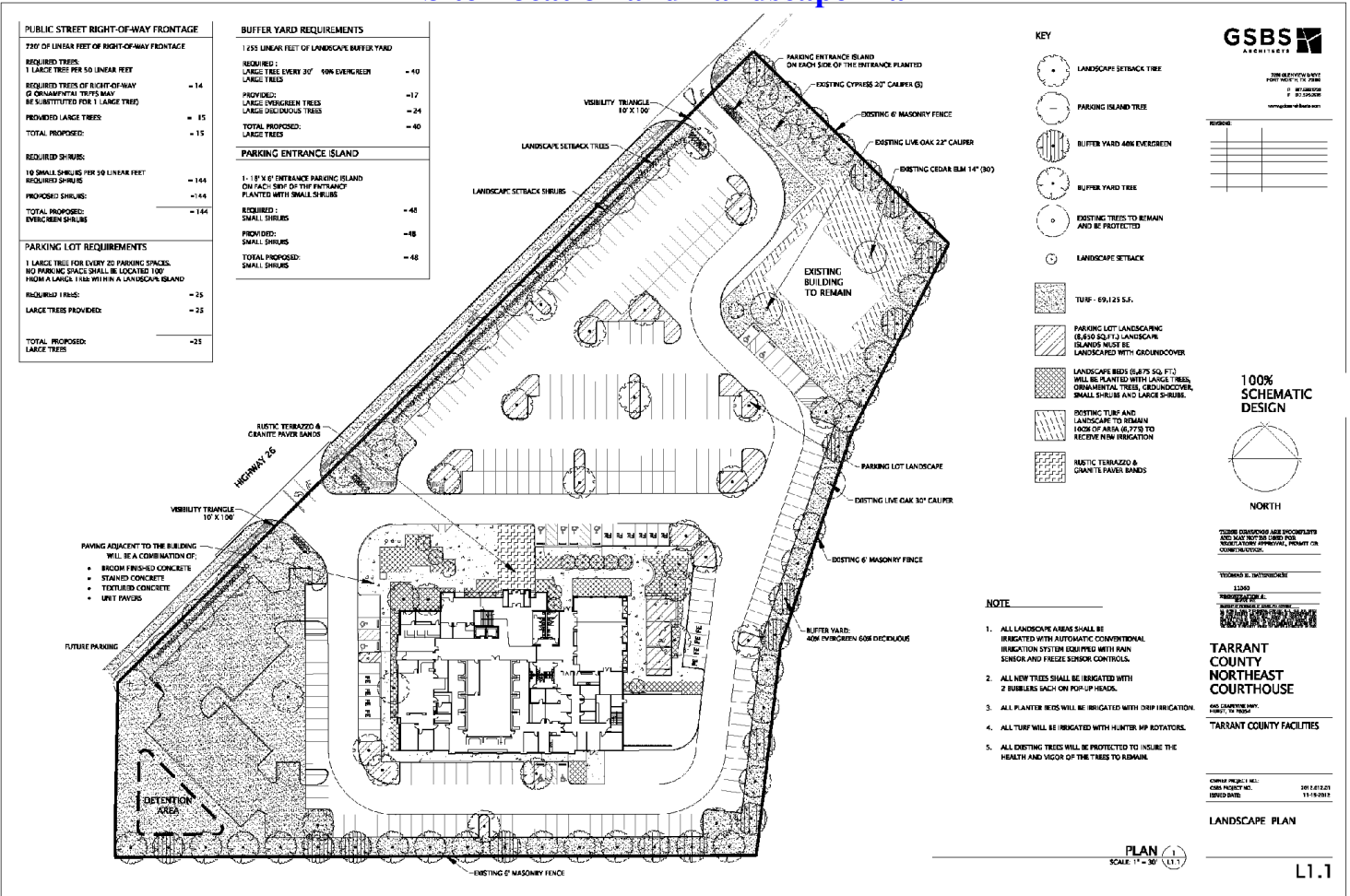

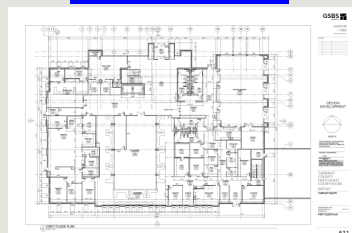

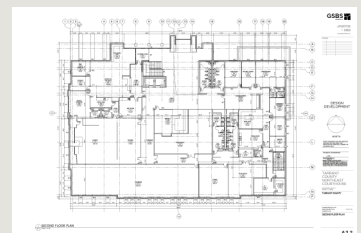

For over 100 years, Catholic Charities Fort Worth (CCFW) has worked to create hope in the community to all who need it, regardless of religion, culture, or creed. We have a zealous goal to end poverty in the 28 county diocese we serve and, through over 40 programs, we are able to serve more than 120,000 individuals and families in need annually. This is made possible by the faithful stewardship indicated by over 90 cents of every dollar donated going directly to client services.

To highlight just one of these programs, the Wheels Transportation program is a 35 vehicle fleet to help transport people to vital doctor appointments, jobs, and interviews. To help supplement this effort by taking services directly to clients, at the end of 2012, our new mobile service unit took to the road. While available to all programs, this vehicle has already provided

mobile ESL classes for refugees and will be a curbside care conduit for the unsheltered homeless.



Another exciting initiative is the Bishop Kevin Vann Dental Clinic, which opened in October, has already managed 605 office visits, 308 new patient visits, and performed 1567 procedures. One of the first patients was a woman who was so embarrassed by her teeth that she was scared to go to job interviews or even to smile. These services empower her to smile with pride. Each of these new projects is intended to help take services further and farther to end poverty.

An Historic Moment in Time Eules Historical Preservation Committee

Hysterical? No Way!

Historical? You bet! The Eules Historical Preservation Committee isn't your typical group of volunteers. This active group is made up of movers and shakers that are dedicated to preserving and promoting awareness of the historical heritage of Eules. This group not only rescued the first brick house in Eules from near demolition, they raised funds to relocate it one block east and thus began the roots of Historic Heritage Park in Eules. The Fuller House was unique because it was Eules' first brick home at a time when most Eules residents lived in wooden farmhouses. This graceful structure was opened to the public in 1998 and provides



a glimpse into how residents lived in the 20s and 30s.

In 2000, the EHPC acquired the Himes Log House, the oldest structure in Eules. Elisha Adam Eules, who gave his name to a growing local village, most likely lived in this home. The log house was relocated and restored using authentic techniques that would have been used in the 1850s.

The committee decided this wasn't enough and most recently created a stand alone museum to honor the history of Eules. The museum opened in September with priceless artifacts from as far back at the 1880s. In addition to the main hall, the museum features a military room, a 1930s kitchen and a 1940s school room. It even has a replica of a wood porch inside the museum that was hand crafted by members of the committee in their spare time...

The museum is adjacent to Historic Heritage Park, located at 201 Cullum Drive. Members of the Committee are appointed by the Eules City Council and serve as docents at the Museum, the log cabin and

Southlake Public Library



Our motto at the Southlake Public Library is “uncommonly friendly service” and we work hard to provide a great customer experience. Our business philosophy is to keep costs low and focus on making sure staff is efficient and productive in order to allow us to increase outputs and yet provide a comfortable and friendly environment.

The Southlake Public Library is on the lower level of the Southlake Town Hall building in the heart of Southlake Town Square. The library is open 10 to 8 Monday – Thursday, 10 to 6 on Friday and Saturday, and is currently not open on Sunday. Due to issues related to the limited floor space in the library we focus on new and popular materials, including a great selection of DVD’s. The library story times are very popular on Tuesdays and Wednesdays. 42,000 attended our youth programming last year. The library’s Summer Reading program reached over 80% of our target market of 1st to 5th graders in the Carroll School District.

The library has just recently added e-content for e-readers like the Kindle, Nook, iPad, and Android devices to name a few. This has proven to be a very popular



addition to the library’s offerings. We also have magazines that are available for your device – just check out the Southlake Public Library’s website www.southlakelibrary.com for details.

Library staff hears time and time again that the Internet will be the end of libraries, or the explosion of e-reader devices and digital content for them, but in Southlake checkouts of print materials still increase every year, and checkouts have grown from 78,000 in 2003 to close to 400,000 in 2012 – does that sound like a business on its death bed?

Established in 1999, Treetops School is Tarrant County’s oldest charter school. The K-12 tuition-free campus is nestled among 20 wooded acres complete with nature trails. While the campus makes it unique, it’s the students’ personal educational experiences that make it extraordinary.

Treetops School’s mission is to inspire students to climb to new heights in service, character, and education by creating a positive, safe community. Class sizes are small, with a total campus enrollment of approximately 350 students. These small classes encourage strong student-teacher relationships. Teachers utilize various instructional methods, such as cooperative grouping, small-group instruction, and project-based learning, to meet the needs of its diverse learners. Treetops School has a strong commitment to community service and has part-



nerships with Mid-Cities Care Corps, Meadows Foundation, Texas’s Adopt-a-Highway campaign, Samaritan House of Fort Worth, the Northeast Tarrant Food Bank, and the Fort Worth Main Street Arts Festival.

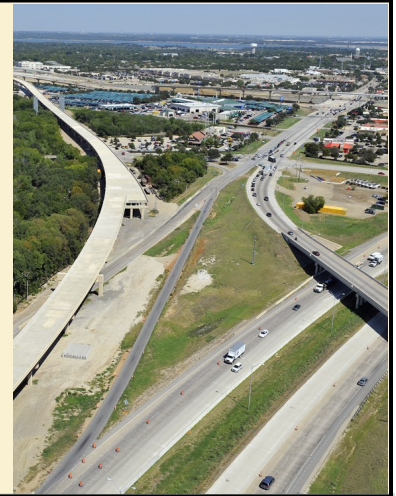

- Crews opened the southbound International Parkway off-ramp to southbound DFW Airport service road. Commuters looking to access the north entrance of DFW Airport will now need to take SH 114 or SH 121 to access the terminals. NorthGate also opened new pavement on Northwest Highway at SH 114 and the eastbound SH 114 frontage road from Southlake Boulevard to SH 26.
- Structures crews finished building the last bridge columns on the

project, located on the northbound International Parkway bridge to IH-635, and completed the final cap pour, located on SH 26.

- In early February, we opened the eastbound SH 114 flyover bridge to southbound SH 121! This new flyover bridge is the longest bridge on the DFW Connector at more than 3,700 feet long. The northbound SH 121 flyover bridge to westbound SH 114 will open this spring.
- In the upcoming months, our paving crews will focus on the east and westbound SH 114 main lanes from William D. Tate Avenue to Main Street and the northbound International Parkway off-ramp to IH-635.

- The transformation of the NTE corridor continues! Major upcoming milestones include the completion and opening of the new Hurstview bridge and the opening of sections of new eastbound frontage roads and main lanes along SH 121/183. In the west segment along IH 820, there are several long-term ramp closures in place; please check our website (under Project Overview/Visuals/Maps) for east and west segment ramp closure maps for the upcoming month so you can

- Completion is nearing on the \$19 million reconstruction and widening of Golden Triangle Boulevard. Traffic will be shifted to its permanent configuration in February. Daytime lane closures will be necessary to complete the remaining median, sidewalk and landscape items. The Golden Triangle Boulevard project is rebuilding the two-lane road to a four-lane divided roadway with raised, grass medians from I-35W to U.S. 377.



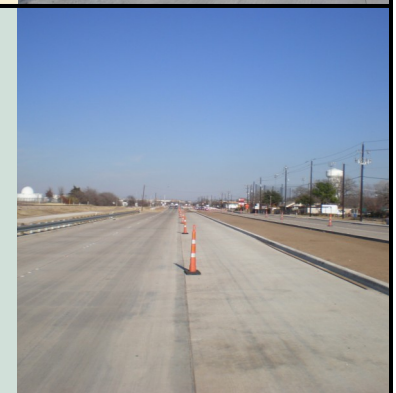

- In Grapevine, traffic is now on the permanent north and southbound lanes. Two lanes of traffic will be maintained in each direction while the medians are completed. Additional upcoming construction items include the installation of decorative concrete medians, planting of trees and shrubs and permanent signal installation. Completion is estimated for summer 2013.
- In Colleyville, the reconstruction of State Highway 26 began in July. The \$11.4 million project from Brumlow Avenue/Pool Road to John McCain Road will widen the road to three lanes in each direction with raised curb medians and left turn bays. As part of this project, the bridge over Big Bear Creek will also be reconstructed. Construction continues on the northbound lanes and includes drainage improvements and the installation of box culverts through spring of 2013. Two lanes of traffic will be maintained during peak driving times. The project is estimated for completion in 2014.

- The Southlake Public Works’ Streets and Drainage division will be extending the southbound right turn lane on Randol Mill Avenue at FM 1709 (Southlake Blvd.) over the next several weeks. Since the opening of Phase 1 of FM 1938, which widened Davis Blvd. through Westlake from SH 114 to the Randol Mill Bend, southbound commuters have been experiencing significant traffic backups near the intersection at FM 1709. These interim improvements will increase the capacity of traffic flowing through the intersection now and reduce the current congestion in the afternoon peak traffic hours by creating a longer right turn lane storage bay and will allow more vehicles into the intersection making it more efficient.
