COMMISSIONER'S CORNER

I want to thank all of the great people who participated with Team Fickes in the 2011 LifeGift 2nd Chance Run on May 14. This was our 4th year to participate in the run which promotes organ donation awareness. This year we had three different events: 5K Run, One Mile Run, and a Pancake Fun Run! A great time was had by all who attended.

Our 2011-2012 Budget is proving to be challenging. There doesn't appear to be any additional revenue and the reduced State budget will burden counties and cities with additional services that the State had previously funded. These reductions will probably include Juvenile Services, MHMR, health care, bridge repair, jail populations, and many other services. On the County items, we will be reducing costs in all areas of our operations, and any other areas where we might save some dollars. We will be working on the budget most of the summer and I would welcome your suggestions or thoughts.

This month we are featuring Mayor Harry Jeffries of Watauga in our "Spotlight on the Mayor" article (page 2). Mayor Jeffries is a very respected mayor and public servant. We are all thankful for the hard work Mayor Jeffries does for Watauga and NETC.

In this edition we have an article about the new Bedford Library (page 5). One of the great things about this facility is not mentioned in the article! This great facility is in one of the many abandoned Food Lion stores that were built in many

cities in NETC during the early 1990's. Bedford has by far done one of the best jobs in rehabilitating this facility and should be congratulated for such a great job.

"Empowering Seniors 2011" will be coming on Friday, October 7, 2011. This has become one of our best and well attended events. Last year we had over 900 Seniors and Boomers attend. We have workshops, health screenings, vendors, entertainment, food, door prizes and great speakers. And it's all FREE--see page 3 for information.

On the transportation front, we have numerous projects under construction. The DFW Connector is nearing 35% completion. This project is ahead of schedule and is moving very quickly. The North Tarrant Express is fully under construction and we should start seeing major improvement monthly. North Tarrant Parkway in NRH and Keller is moving very fast and should be completed within the next 4-5 months. This project has moved quickly because of the attention paid by the Public Works Directors in NRH and Keller. If you haven't noticed, SH 26 in Grapevine is also under construction from SH 114 to Pool Road. This project should be completed in mid-2012. The Colleyville City Council voted to approve the start of construction of SH 26 from Pool Road to 1,000 feet south of John McCain Road. This project may

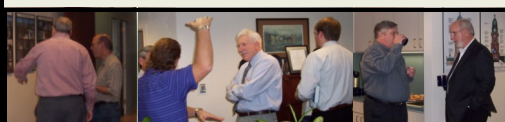

Watauga Mayor Harry Jeffries has an Associate's Degree from Nassau Community College and numerous Certificates of Achievement from the Texas Municipal League. He was an employee of American Airlines from April 1967 - April 2003. Mayor Jeffries has been a resident of Watauga since July 1981. He was a member of the Parks and Recreation Board from September 1983 - December 1988 and served as Co-Chairman and Chairman. He was a Charter Member of the Park Development Corporation from July 1994 - October 1998 and has been a Charter Member of the Crime Control and

Prevention District since 1992, serving as Secretary and President. Mayor Jeffries is a Charter Member of Saint Elizabeth Ann Seton Catholic Church. He has served as President of Region VIII of the Texas Municipal League, and on the Board of Directors of the Texas Municipal League representing the cities in Region VIII. He served as President of the Association of Mayors, Councilmembers and Commissioners (AMCC) from February 2005 - February 2006. Mayor Jeffries is also the 2008 Excalibur Award winner presented by the Northeast Chamber of Commerce for his leadership in representing the City of Watauga. In February 2011, the Texas Municipal League presented Special Recognition to Mayor Jeffries for fulfilling the required continuing education requirements of the TML Institute for 15 consecutive years. Mayor Jeffries is the only person to accomplish this achievement, and it has earned him the designation of Certified Municipal Official. He and

his wife RuthAnn have been married for 41 years and have a son and daughter, as well as three grandsons.

Keller Senior Activities Center

The City of Keller's Senior Activities Center (KSAC) has something for everyone 55 years and older. The Center focuses on four major programming areas that include: Exercise, Education, Trips and Social gatherings.

Join the fun and get fit with one of our three exercise classes instructed by certified professionals. Energizing Yoga class promotes flexibility, balance, mind-body awareness and basic breathing followed by a series of gentle energizing yoga postures. Fit and Fab is a low-impact workout designed specifically with seniors in mind. Tai Chi is a great class to practice movements and techniques that may help with symptoms of arthritis.



Educational programs offered at the KSAC include computer courses such as: new user class, internet, intermediate, advanced, and a new digital photography course. Several times each year, the Keller Senior Activities Center will host the AARP Driver's Safety Class taught by AARP volunteers. Volunteers lead classes



on quilting, knitting and crochet, as well as beginning and advanced ceramics. Many more classes are added throughout the year.

Day trips to area attractions such as museums, theater performances, casinos, and festivals are always a big hit. Participants can enjoy the festivities and leave the driving to KSAC staff. Staff work with tour companies to offer extended overnight trips several times a year to destination locations in the United States and abroad.

Social gatherings at the KSAC are bustling with excitement as we celebrate the holidays, host dances, murder mystery dinners, birthday breakfasts and game tournaments. Lunch is served daily Monday through Friday at 12 noon through

a partnership with Senior Citizen Services of Greater Tarrant County, Inc. Additionally, the Northeast Transportation Service (NETS) offers door-to-door transportation services to residents who are disabled, or age 55 or older. Every July, the KSAC hosts PastaPaloosa, a fundraising spaghetti dinner, concert and silent auction. Monies raised at this event are used for program equipment. This event is open to the public and is a great opportunity for the community to come and see all the services the center has to offer.

Bedford Public Library



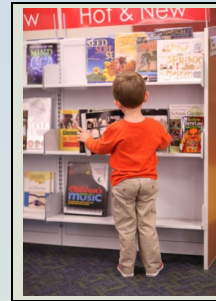

RFID Technology

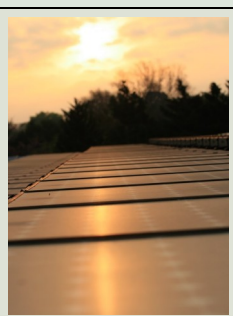
The new Bedford Public Library will be using state-of-the-art Radio Frequency Identification (RFID) technology to improve customer service at the new facility. This technology allows patrons to checkout by scanning their library card and placing items in a stack on a pad. In addition, 50 foot conveyor belt has been installed connecting the drive-up book drop to a 9-bin automated sorter. The conveyor and sorting system will move library materials and sort them by category into separate bins.

An Historic Moment In Time

1895 Courthouse Clock Tower Historically Sensitive Rehabilitation Project

The 1895 Courthouse is the crown jewel of Tarrant County. It represents civic pride, stability, justice. Its clock tower has kept time for the community and its tower bell has called courts to order for 116 years.

However time is an enemy of buildings. Weathering has caused the clock tower's cast iron balustrade fasteners to rust away and steel bracing to fail, allowing the cast iron cornice, balusters and end boxes to shift out of place. In 2009, a 400 pound cast iron end plate detached and fell, punching a hole in the copper roof below. The holes in the 1920s copper dome (the copper is attached to the building with wire) and granite block joints have allowed rain water to wash out several areas of the interior tower brick mortar. The brick is

the building's support structure; it's not good when the mortar washes away.

In 2009, Art Weinman Architects performed a comprehensive study on the clock tower for rehabilitation. Commissioners Court allocated \$5 million for the clock tower's historically sensitive rehabilitation project.

The scope of the rehabilitation project includes 1) complete removal, repair and reassembly of the clock tower lower cast iron balustrade, 2) removal of the dome copper cladding and installation of a new stainless steel decking, new butyl based waterproofing membrane and new copper

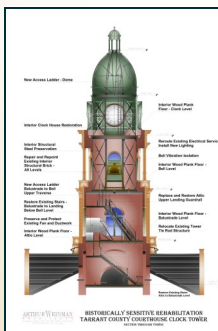


1895 Courthouse undergoing the Rehabilitation Project.

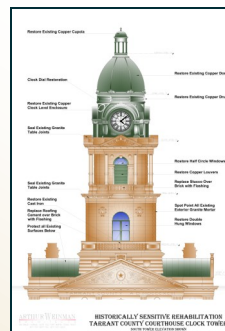


cladding, 3) repointing the interior brick mortar joints, 4) replacing warped and broken wood flooring, 5) rehabilitating the clockworks and clock faces, 6) installing anti-vibration supports to prevent the tower bell from transferring vibration to the building as it does now.

The goal of the project is to have an attractive, serviceable, weather tight clock tower that will keep time for another 116 years and beyond. The rehabilitation work should be completed in 2012.

Chances are that either you or someone you know has received a jury summons. While some people aren't too excited to be called to serve, most people recognize the importance of their civic duty. For the citizens that are called, Jury Service is becoming more and more convenient to serve. Now, when jurors are summoned to report, they are given the option of answering their jury summons in person or

using the online system. The Jury eResponse online system is very convenient to use. Jurors can use the online system to complete exemptions, disqualifications or reschedule their first appearance to a later date. Jurors using eResponse, who are qualified to serve can get their court assignment and court questionnaire online. This allows the juror to report directly to the court, bypassing the jury room until dismissal. Many of the court assignments will have a delayed appearance time, even as late at

1:00pm. It has proven to be a great cost savings to the county as well. If the court is able to provide advanced notice of a cancellation, the jurors can be emailed with instructions not to report and their service is complete. The website for Jury Services is www.tarrantcounty.com/ejury. Approximately 5,000 summons are mailed each week in order to serve the needs of our 51 courts. Tarrant County Jury Services falls under the direction of the Board of District Judges. The jury room staff consists of Paula Gaiamo Morales, Jury Bailiff; Debbie Brown, Asst Jury Bailiff III; Monica Andress, Asst Jury Bailiff II; Judy Lowe, Asst Jury Bailiff I; Cathy Giles, Asst Jury Bailiff I; and Linda Alvarado, part-time clerk. The Central Jury Room is located in the Tim Curry Criminal Justice Center at 401 West Belknap in downtown Fort Worth.

Answer: Rio Grande River, Red River, and the Sabine River.

The Tarrant County Fire Marshal's office reminds you that if you conduct an outdoor burn you must:

1. Stay with the fire at all times while it is burning.
2. Only burn from sun up to sun down. **No burning at night!**
3. Have water available
4. **Do not burn outdoors if the wind speed is higher than 20 MPH.**
5. Consider your neighbors.
6. Be extremely careful.
7. Contact your local fire department before you conduct outdoor burning.
8. **Only burn brush, tree limbs, grass clippings and leaves. No trash or building materials. Be Safe and Careful!!**

1)The structures group reached a significant milestone this May! The DFW Connector Project opened the following bridges to traffic north of the DFW Airport: southbound SH 121, westbound IH-635 and southbound SH 1121 on-ramp from Bass Pro Drive to southbound International Parkway (pictured right).

2)Currently, the intersection crews are finishing grading work along the westbound SH 114 frontage road at William D. Tate Avenue. All drainage work has been completed in these areas and concrete paving is scheduled for beginning of June.

3)We have finished permanent paving of the eastbound SH 114 main lanes from the Texan Trail off-ramp to the Texan Trail bridge.

Bluebonnet Contractors has ramped up construction activities on the North Tarrant Express project. NTE Mobility Partners right of way team and BBC utility relocation team are continuing to move forward with acquiring the necessary properties and approvals to implement additional construction in the corridor. The direct connect from westbound SH 183 to northbound SH 121 is permanently closed while a new connection is being built. The North Tarrant Parkway project construction continues this month with additional paving activities ongoing in North Richland Hills and Keller. NTP Drivers are catching their first glimpse of the future 6-lane section in North Richland Hills now that paving activities have resumed at the far east end of the job. Once the remainder of the pavement is in place, traffic will be allowed to use the new lanes and the contractor will finish the parkway grading in preparation for sidewalks and landscaping. Street light bases have recently been placed in portions of the project as the entire corridor will receive lighting upgrades.

Construction work on FM 1938 was delayed due to rain and severe weather the D/FW Metroplex experienced over the previous couple weeks. However, work has started back up and the contractor is continuing to make some progress as they mix and stabilize the road sub grade from Dove Road south to approximately the Vaquero Club Drive entrance. We anticipate the contractor to start paving in this section within the next few weeks. The contractor has started pouring concrete at the Solana/Dove intersection. This work will include pavement enhancements approved by the Town of Westlake. Once completed, we will start to see traffic being diverted to the newly constructed sections in order for the contractor to begin working on the existing roadway sections. Crews also continue to work on retaining walls and dirt excavation.
