Employee Spotlight



B. Glen Whitley
Tarrant County Judge



Born and bred in North Texas, Tarrant County Judge Glen Whitley is a civic leader and certified public accountant whose first job, when he was 15, was scooping ice cream at a Carnation store in Grand Prairie, the town where he grew up.

He graduated from Grand Prairie High School in 1971 and earned a Bachelor's of Business Administration from the University of Texas at Arlington in 1976. He began his career at Ernst & Ernst and co-founded the Whitley Penn accounting firm with offices in Fort Worth and Dallas in 1983. He was elected a County Commissioner representing Northeast Tarrant County in 1996 and County Judge in 2006.

Judge Whitley is a regional and state

leader on matters of efficiently run government, transportation, sustainable communities, air quality and youth and children's issues.

He is currently chair of the metropolitan planning organization for the North Central Texas region and a past president of the Texas Conference of Urban Counties. He is the National Association of Counties 1st Vice President and a member of the state Task Force on Indigent Defense.

Judge Whitley has long been active in education, health and social services issues. He helped create the Tarrant Youth Recovery Campus and served for many years on the board of the Alliance for Children. He is a former Hurst-Eules-Bedford school district trustee and served on the Texas Health Resources board and its executive committee.

A little known fact about Judge Whitley is that he was a Mouseketeer. His father was stationed at the Los Alamitos Naval Air Station in the early 1960s and the Whitleys lived in Anaheim, California, about two miles from Disneyland. The Judge even went to the Walt Disney Elementary School in Anaheim. "Whenever

anybody came to California to visit from Texas, I was their Disneyland tour guide," he said.

Judge Whitley and his wife, Brenda, live in Hurst, Texas, and have three grown children and three grandchildren.

TARRANT COUNTY CLERK

The County Clerk's Office is committed to the delivery of high quality, cost efficient services to citizens. This is evidenced by the myriad of services available at the sub-courthouses, including those located at: 645 Grapevine Highway in Hurst, and 1400 Main Street in Southlake. There you can register a business name, obtain a marriage license, or get certified copies of those documents and

birth and death records. It is important to note – birth certificates obtained from these locations are produced from a remote access system operated by the State of Texas, and are considered an "abstract" copy. They are official and satisfy the requirements of most government offices, except those of the U.S. Passport Office. For passports, you'll need a "long form" of your birth certificate, which can only be purchased through the Registrar's office where the birth took place. It is the goal of the County Clerk's office to make the full form birth certificates available from the sub courthouses in the future.

Since 1850, the County Clerk has been the "KEEPER OF THE RECORDS" for Tarrant County as well as the Clerk of the Commissioners Court. Additional duties of the County Clerk include: maintaining accurate records of real property, supporting criminal courts, civil court and probate courts.

The County Clerk's Office has been very innovative in its use of technology to man-

age their records, preserve them from deterioration, and protect them from natural disasters. It has also enabled citizens to transact business from their homes or business using the internet.

In 1993, the County Clerk's Office established a highly recognized Recycling Program. It was one of the first of its kind in the nation. Originally, the program focused on the recycling of paper within Tarrant County governmental offices through recycling at individual desks. It has since grown to include interlocal agreements with 44 outside entities. In that time over 15 million pounds of paper have been recycled that would have otherwise been in our landfills.

ECONOMIC DEVELOPMENT - BEDFORD

Bedford continues to grow as a medical and health care hub for the Dallas/ Fort Worth Metroplex. Texas Health Harris Methodist HEB is undoubtedly the anchor for this business sector. Close behind is the headquarters for Texas' largest blood center Carter Blood-Care, employing over 800 people. A number of medical-related developments are adding to the trend. The construction of a new specialty hospital and a specialty clinic is underway, complementing the wide array of medical services now available in Bedford.

Caddis Partners, LLC to Develop Reliant Mid-Cities Rehabilitation Hospital in Bedford, TX



Caddis Partners announced the scheduled development of Reliant Mid-Cities Rehabilitation Hospital, a three-story facility consisting of 65,000 square feet, in Bedford, TX. Construction financing was secured August 28, 2009 and groundbreaking was September 16th, 2009, with an anticipated 12 month construction timeline.

The hospital will be a state-licensed, acute freestanding 40 bed rehabilitation hospital and will also include a separate in-hospital unit consisting of 20 skilled nursing beds for a total of 60 beds. The state-of-the-art facility

will provide nursing and therapy staff, ancillary services, and supplies to treat patients who require intensive inpatient rehabilitative care and accommodate selected skilled nursing patients with a primary need for limited rehabilitation services.

The development site is on the northeast corner of State Highway 121 and Bedford Rd. and is an ideal location for an inpatient rehabilitation hospital due to its close proximity to Harris Methodist HEB Hospital, North Hills Hospital, and Baylor Regional Medical Center at Grapevine. The tenant is a joint venture between Reliant Healthcare Partners and a group of physicians. The rehabilitation hospital will accommodate the current undersupply of rehabilitation and skilled nursing facilities in the Mid-Cities region.

Additional tenants in this center include boutique shops such as **Hoola Hoops** a clothing and unique gifts store, and **That's Haute**, a full interior design service.

Precinct 3 Busy With Road Projects

We recently completed rehabilitation of Lonesome Trail and Katy Road between Oak Haven and Mt. Gilead as well as the surface rehabilitation on Bonds Ranch between Highway 156 and Harmon Road. In late September we started the rehabilitation of Old Denton Road between Thompson and Heritage Trace Parkway. On October 5th we began the rehabilitation of Westport Parkway between Highway 156 and Intermodal Parkway. The projects on Old Denton Road and Westport Parkway will take us past Thanksgiving and possibly past Christmas if we have any inclement weather.

Normal road maintenance projects will be on-going during the winter months including trimming trees back out of the rights-of-way for sight distance safety, and sealing the cracks in the asphalt pavement to prevent water from damaging the road base. We are in the process of working with the cities in Precinct Three to identify street projects for rehabilitation and asphalt overlays to begin in the spring and summer of 2010.

OPEN ARMS PROGRAM

Hope New Beginning
Safety



Formed in 1988, the Community Enrichment Center's Open Arms Program is one of only a few programs in Tarrant County providing long-term care to victims of domestic violence. The program's goals are to help victims heal and successfully transition to a healthy life away from violence and abuse. The two-year program can provide safe shelter to 24 women and their children at any point in time.

In addition to housing, families receive case management, professional counseling, group therapy, food and clothing, and education and employment assistance. Open Arms encourages women to work towards self-sufficiency by improving their education and job skills so they can support their families on their own and not return to their abusers.

In addition to providing direct services to victims, Open Arms staff members answer hundreds of emergency calls each year from women seeking assistance and referrals to resources in Tarrant County. Staff members also speak to churches, schools and community groups about recognizing signs of domestic violence and how to help victims and their children.

Some of the ways the community can help women and children in Open Arms are:

- Make a financial contribution to the program.
- Donate food, household items and/or furniture.
- Volunteer to help with child care during group therapy or volunteer at special events.
- Sponsor the Seasons of Hope event benefiting families in Open Arms.
- Host a food drive anytime during the year.
- "Adopt" a child or a Mom during Christmas to provide clothing and gifts for the holidays.

An Historical Moment In Time

HERON CASTLE

On the south shore of Lake Worth stands a castle—a castle with a storied past of gambling, ghosts, a suicide, and para-normal activities.



The castle began as a two-room rock cabin with a connecting dog trot built in the latter part of the nineteenth century. The first to enlarge the cabin was a wealthy Irishman named McPherson who spared no expense in importing wrought iron from Ireland, stained glass windows, decorative fixtures, and furnishings from Europe. Mr. Samuel E. Whiting purportedly won the property in a poker game from McPherson in the late 1920s. Mrs. Elizabeth Whiting personally designed and supervised the construction of the house, which included the rear tower and the round crenellated front wing, and named their home “Inverness” or “Whiting’s Castle”. It is believed that Whiting’s son committed suicide in the

castle and that may account for the rumored ghostly sightings on the property. A major fire seriously destroyed the castle in 1939.

From 1944 to 1954, Vultee Aircraft Corporation (now General Dynamics) leased the property to entertain visiting businessmen and it served as a private club for their employees.

The next noteworthy period for the Castle was in the mid 70’s when Tony and Marian Vann took possession of the property and undertook some major restoration work. Marian Vann learned how to work with stained glass and set about repairing and replacing the broken or missing window panes.



The Vanns offered adult self-improvement programs to the public and named their home “Castle St. Michael”. Unfortunately a second fire gutted the building causing major damage to the structure.

Once again, the castle arose from its ashes when Mr. John Pigenburg and his

brother-in-law, Richard Ruiz, of Hawaii purchased the property in the mid 80’s. They began an extensive modernization and renovation project over a three-year period that included roof repair, rewiring, replacing loose stone, and adding unique architectural features.

It was their intention to open the castle to the public for tours on weekends, but the project was not completed.



In its heyday, the castle was a magnificent structure that hosted such notables as then General Dwight D. Eisenhower, Eleanor Roosevelt, and actor Jimmy Stewart during filming of “Strategic Air Command” at nearby Carswell Air Force Base. Today, only remnants of the castle’s former glory remain. According to the City of Fort Worth, the current custodian of now “Lake Worth Castle” has plans to make the facility into a bed and breakfast. There is some activity on the premises presently with new hope for a brighter future for this unique structure.
