An owner or operator of a vehicle that has been removed and placed in a vehicle storage facility or booted without the consent of the owner or operator of the vehicle is entitled to a hearing, if the owner/operator files with the court, a written request for the hearing, before the fourteenth (14th) day after the vehicle was removed/booted (strike one). In computing time under this subsection, Saturdays, Sundays, and legal holidays are excluded. A hearing under this chapter shall be in the Justice Court in the County in which the vehicle was towed/booted. All documentation MUST be filed with the original(s) and 3 copies.

Note: A person who fails to deliver a request in accordance with Occupations Code, Section 2308.456 (a) waives the right to a hearing. \*All persons should consult the Texas Occupations Code Chapter 2308 for complete information.
