Weekly Arbovirus Surveillance Report: MMWR Week Jul 30-Aug 5, 2023



Week 31 Summary

- 177 mosquito pools* have been tested in NTRL from week 31
 - Year-to-date NTRL has tested a total of 2857 mosquito pools
- 20 mosquito pools tested positive for WNV this week:
 - Arlington (7) Bedford (2) Euless (2) Fort Worth* (3) Grapevine (2) Hurst (1) Keller (1) Mansfield (1) Southlake (1)
- There have been 0 imported human cases of SLE or Zika in 2023. There has been 1 case of Dengue Fever.
 - There have been 3 human cases of West Nile disease.
- Average number of mosquitoes/trap include:
 - *Culex* spp: 21.6
 - *Aedes aegypti*: 1.0
 - *Aedes albopictus*: 2.7

Figure 1. Average Number of Female *Culex* Species Per Trap and Vector Index by Collection Date, Tarrant County, 2022-2023

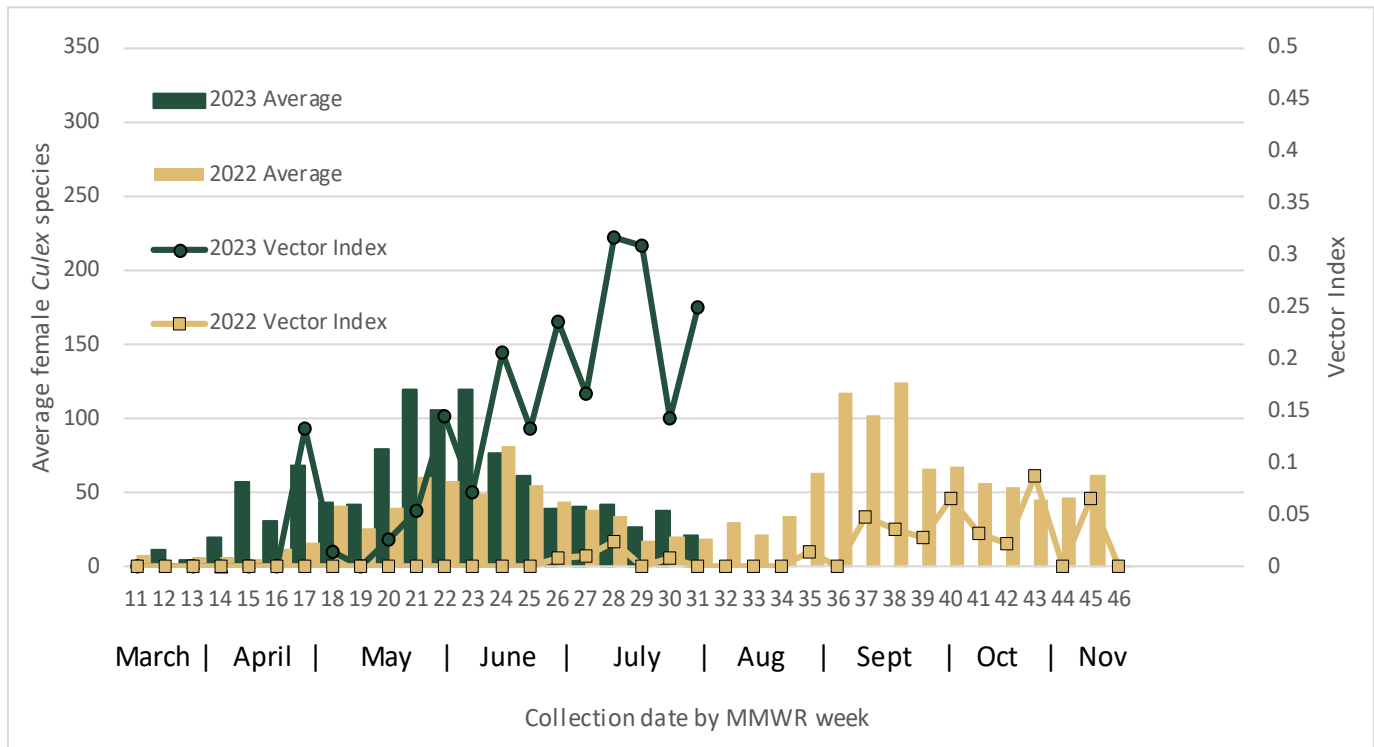
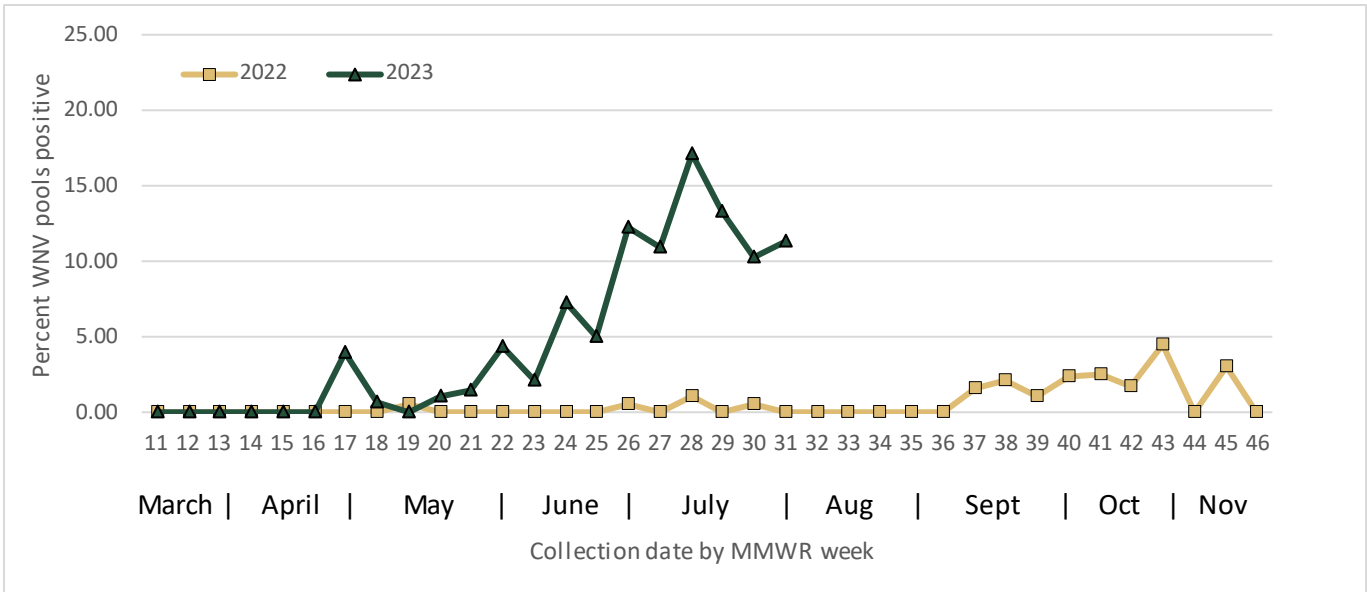


Figure 2. Percentage of Mosquito Pools Positive for WNV by Collection Date, Tarrant County, 2022-2023
