## Weekly Arbovirus Surveillance Report: MMWR Week Sep 24-Sep 30, 2023



### Week 39 Summary

- 170 mosquito pools\* have been tested in NTRL from week 39
  - Year-to-date NTRL has tested a total of 4149 mosquito pools
- 8 mosquito pools tested positive for WNV this week:  
Arlington (1) Fort Worth\* (3) Grapevine (1) Haltom City (1) Hurst (1) Mansfield (1)
- There have been 0 imported human cases of SLE or Zika in 2023. There has been 3 cases of Dengue Fever.
  - There have been 9 human cases of West Nile disease.
- Average number of mosquitoes/trap include:
  - *Culex* spp: 109.1
  - *Aedes aegypti*: 11.2
  - *Aedes albopictus*: 1.3

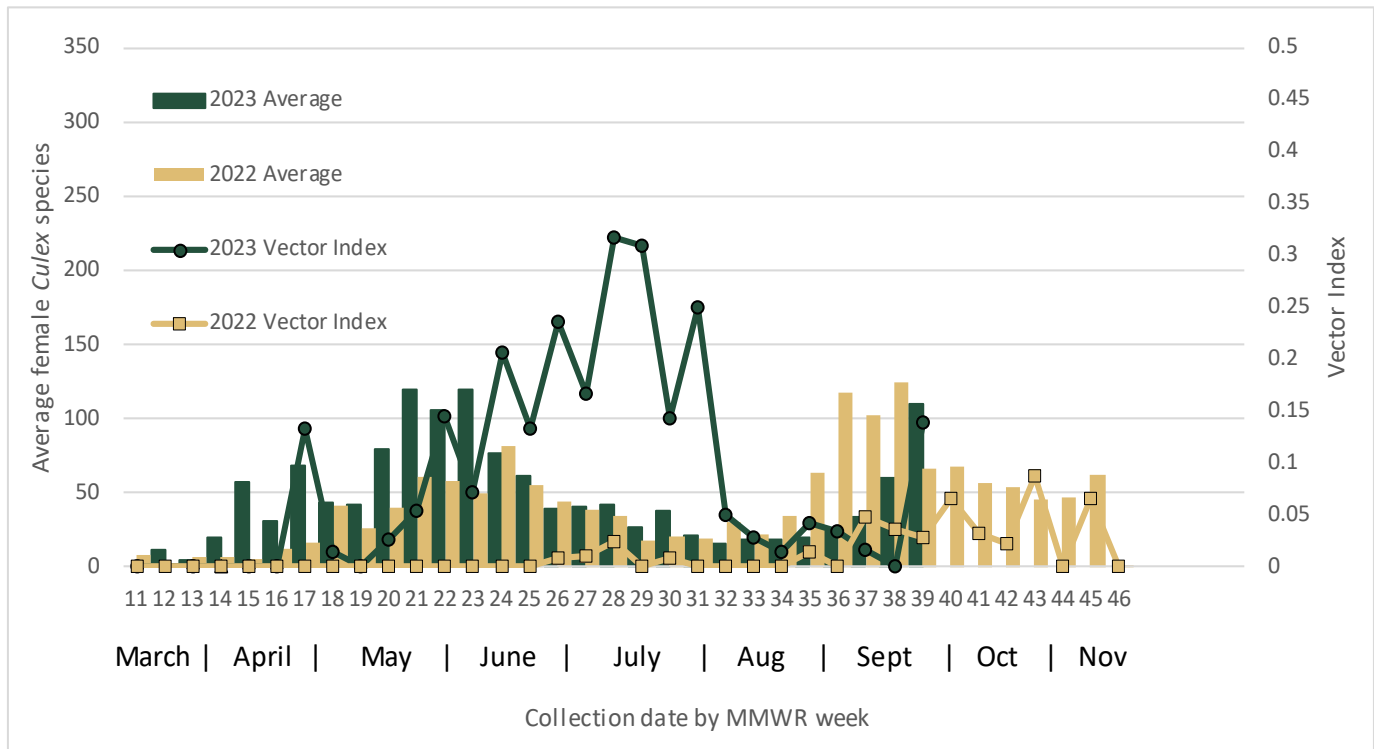

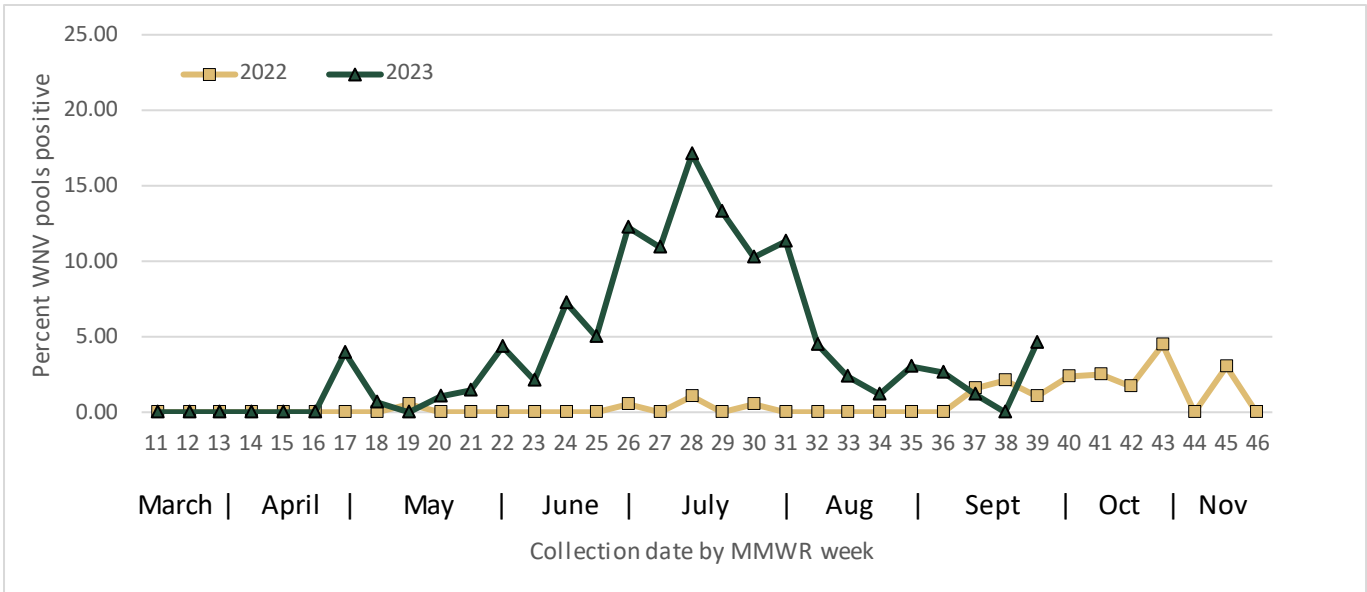
