Key Findings

- Overall, the health of Tarrant County is comparable to that of the state of Texas and the United States, and shows trends in most of the health indicators similar to that of the state and the nation.
- By the year 2001, Tarrant County had met 20 percent of the corresponding Healthy People 2010 objectives for selected health indicators. These include adolescent pregnancy, diabetes mortality, hepatitis A, enteric diseases, and child abuse and neglect.
- During the years of 2000 and 2001, Tarrant County showed improvement in ten of the health indicators. Health indicators that showed progress include poverty, child mortality, adolescent pregnancy, gonorrhea, new HIV cases, hepatitis A, enteric diseases, child abuse and neglect, and intentional injury related deaths.

In contrast, health status declined in ten health indicators and remained unchanged in 15 health indicators in this time period. Health indicators that showed a decline include unemployment, infant mortality, low birth weight infants, diabetes mortality, primary and secondary syphilis, hepatitis B, tuberculosis, air quality, substance abuse deaths and unintentional injury related deaths.

 Of the seven health domains (refer to page 3), environmental health showed the greatest improvement between 2000 and 2001, followed by infectious diseases and maternal and child health. Chronic diseases remained unchanged.





In 2001 Tarrant County Public Health, supported by a Texas Department of Health Innovation Grant, launched the Monitoring & Assessment Project

(M.A.P.) with a primary goal to create a comprehensive community health report card. This report establishes a baseline for accurate, periodic assessment of our community's progress towards improving health. The county's health indicators are based on the statewide Texas Strategic Health Status Indicators and also are being compared to Healthy People 2010 benchmarks.

Core health indicators include:

- Domain I. Community Profile
 - demographic and socioeconomic data, quality of life, health resources
- Domain II. Maternal & Child Health
 - infant mortality, child mortality, prenatal care, adolescent pregnancy, low birth weight, immunization
- Domain III. Chronic Diseases
 - cardiovascular disease mortality, cancer mortality, diabetes mortality, chronic obstructive pulmonary disease mortality, stroke mortality, obesity morbidity, diabetes morbidity
- Domain IV. Infectious Diseases
 - STDs, body fluid-borne pathogens, tuberculosis
- Domain V. Environmental Health
 - enteric disease, hepatitis A, lead poisoning, air and water quality
- Domain VI. Social & Mental Health
 - suicide, substance abuse, child abuse and neglect, crime arrests, divorce, mental illness
- Domain VII. Injury
 - intentional injuries, unintentional injuries

This report card shows Tarrant County's health status and progress in selected health-related indicators. See page five for an explanation of how to interpret this report. Healthy People 2010 is a comprehensive nationwide health promotion and disease prevention agenda established by the U.S.

Department of Health and Human Services in January 2000. Healthy People 2010 contains 467 objectives designed to serve as a road map for improving the health of all people in the United States during the first decade of the 21st century.

Two overarching goals of HP 2010 –1) increase quality and years of healthy life, and 2) eliminate health disparities--served as a guide for developing objectives that will actually measure progress.

The objectives are organized in 28 focus areas, each representing an important public health area. Each objective has a target for improvements to be achieved by the year 2010.

HOW TO INTERPRET SCORES






HOW TO INTERPRET CHARTS

For each indicator, the report presents Tarrant County charts for the years 2000 and 2001 (blue bars) compared to Texas and U.S. 2001 (grey bars). For some indicators, the 2001 data was not available for the state of Texas and the nation. In these cases, year 2000 data was used for comparison. The corresponding HP 2010 objectives are presented as vertical red lines which indicate Tarrant County's progress toward meeting the stated goal (see example below). When there is *no* HP 2010 objective that directly corresponds with a Tarrant County health indicator, a related HP 2010 objective is referenced below the chart.






• Unemployment







Interpretation of Score Health Status (+ improved / 0 no change / - declined) Red line: HP 2010 objectives












Interpretation of Score: Health Status (+ improved / 0 no change / - declined) Red line: HP 2010 objectives






Interpretation of Score: Health Status (+ improved / 0 no change / - declined) Red line: HP 2010 objectives
